General information about cookies

Cookies are small text files that are stored on your computer by the websites you visit. They contain session data related to your use of a website, which can be used by the website concerned for various purposes, e.g. to make your website visit more efficient or to measure activity on the website.

We make a distinction between essential cookies and non essential cookies.

Essential cookies are cookies that we need for the proper operation of our website. Essential cookies may for example save your language preferences through our different webpages, or allow you to complete a communication form and send your request or remark to us.

For the use of non essential cookies, we will ask your permission, by means of our Cookie Banner that will pop-up when you first visit our website. You may withdraw your consent for the future, by changing your cookie preferences in the footer.

We may update this cookie statement from time to time. If the changes impact cookies for which you have already provided your consent, or if we add additional cookies, you will be redirected through our cookie banner.

The cookies we use are the following:

__gat__UA__	This cookie is associated with Google Universal Analytics and is used to throttle the request rate - limiting the collection of data on high traffic sites.	Expires at the end of the browser session	Yes --> Google
__hjid	Hotjar cookie that is set when the customer first lands on a page with the Hotjar script. It is used to persist the Hotjar User ID, unique to that site on the browser. This ensures that behavior in subsequent visits to the same site will be attributed to the same user ID.	1 year	Yes --> Hotjar

Information about Google analytics

This analytical tool installs cookies that we use in order to quantify the visits (traffic) on the website and the behavior of the users on our Website. This allows us to know how many times a particular page has been consulted, a video has been viewed, a button has been clicked. We use this information only to improve the content of the Website or as a basis for a new campaign by determining certain topics of great interest. You can find more information in the Google Analytics tool.
